



to all DepEd Offices and Schools in the Division**

Attached is Regional Advisory, re: **Imposition of Adapted Safety Measures to All DepEd Offices and Schools in the region** as result of an Inter-Agency Emergency Meeting called for by DILG X on September 5, 2016. This office likewise announce to all district offices and schools to adapt safety measures enumerated hereunder.

1. Security guard/s or school watchman/men on duty must check all incoming visitors and vehicles to offices/schools.
2. All plate numbers of incoming visiting vehicles must be recorded upon entering the vicinity of the office/school. Visitors are also advised to log in the visitor's logbook.
3. All personnel in the office/school must be vigilant at all times in his/her surroundings.
4. Teachers are directed to advise their pupils/students to be alert and watchful at all times at their own school surroundings.

All other safety and security measures can be adapted by school administrators for the benefit of the learners, faculty and staff, and the community in general.

Subject: **Imposition of Adapted Safety Measures to All DepEd Offices
and Schools in the region**

Reference: Emergency Interagency Meeting called by DILG-X, September 5, 2016

1. This Office announces to adapt safety measures to Region/Division Offices and schools in the region.
2. The security guards/school watchmen on duty shall impose to check all incoming visitors and vehicles to offices and schools. The drivers shall be requested to open the wind shield and baggage compartment of the car to visualize the passengers or cargoes inside. These includes all types of vehicle whether public utility (i.e. taxi) or privately owned.
3. All plate numbers of incoming visiting vehicles must be recorded upon entering at the vicinity of the office or a school.
4. All personnel in the office and school shall be vigilant in his/her surroundings.
5. Teachers are directed to advise their pupils and students to be alert and watchful at their own school surroundings.
