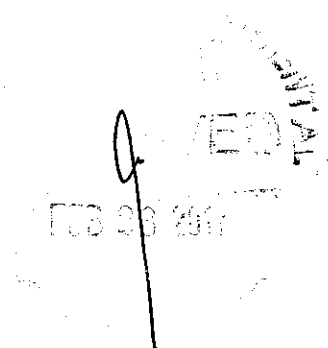

Seven Municipalities of MORESCO II are within the division of Misamis Oriental where the following principals/teachers are members of their respective MSEAC:


